Tree Farms are more than pine plantations and Christmas tree growers.

They are varied in nature and contain many different habitats and stages of forest regeneration. Tree Farmers are part of a select group who share a commitment to protecting watersheds and wildlife habitat, conserving soil, providing recreation opportunities, and practicing sustainable timber harvesting. Tree Farms in Vermont with up-to-date inspections are third party certified in the American Tree Farm System, under the Program for the Endorsement for Forest Certification (PEFC).
