CORRECTION ON H.697 CURRENT USE REPORT

Many thanks to the sharp eyes that caught our error in the report last week about the progress of H.697, the Current Use changes to include reserved forestland.

The bill did NOT pass the House and head to the Senate as reported; it is actually on the Action Calendar on March 8, 2022, for a Third Reading. The recorded vote of 83-43 was after a floor debate, which sends it to the next step. If the House passes the language on March 8, it will THEN head to the Senate, probably Senate Natural Resources.

Also, a quote attributed to Commissioner Michael Snyder about being less than 10 parcels that would qualify actually occurred during the floor debate and was mentioned by one of the representatives. The Department of Forests, Parks & Recreation report actually suggests there are more than 7,700 parcels in Vermont that could qualify for the new program if they met the criteria mentioned below.

This is the reference for "Considerations for a Reserve Forestland Category in Vermont's Use Value Appraisal Program""

To ensure that if this approach (H.697) were implemented, it would result in only a negligible expansion of parcels eligible for enrollment in UVA; only those parcels that have a minimum of 25 total enrolled forestland acres and 20 acres of forested productive soils would be eligible for enrollment of Reserve Forestland. This would mean that only a very limited expansion of eligibility would occur by making eligible those parcels that are currently prevented from enrolling due to existence of a forever wild easement, that also satisfy the acreage thresholds, AND meet the Significant Sensitive Conditions thresholds. Though there has not been a parcel by parcel accounting, it is likely that the number of additional parcels that meet these criteria, and would become eligible if this approach were implemented, is in the single digits, less than ten. Sincere apologies to Commissioner Snyder for attributing a quote that was not only misleading but something he didn't say!
